

Sessions Case No. 81 of 2023

Order No. 02, dated 25.04.2023

Record shows that C/S submitted against 28 accused persons showing four accused persons as absconder.

Record shows that case against accused Shyampada Jana and Badal Maity have been filed for ever vide order dated 18.08.2022 of Ld. ACJM, Contai.

Out of 26 accused persons, accused namely, 1. Amal Maity (CS Sl No.2) , 2. Tapan Mondal (CS Sl No.5), 3. Bishnupada Mondal (CS Sl No.6), 4. Umapada Das (CS Sl No.7), 5. Manoranjan Jana (CS Sl No.10), 6. Pintu Samanta (CS Sl No.11), 7. Gurupada Pramanik (CS Sl No.13), 8. Shaktipada Maity (CS Sl No.14), 9. Narayan Maity (CS Sl No.15), 10. Lakshman Pal (CS Sl No.16), 11. Nimai Pramanik (CS Sl No.20), 12. Sukumar Mondal (CS Sl No.21), 13. Sachin Samanta (CS Sl No.24), 14. Shaktipada Bhakta (CS Sl No.25) and 15. Makhan Bera (CS Sl No.28) appeared by filing v. nama and by filing application prays for permission to remain on the previous bail bond.

Ld. Additional PP files hazira.

Heard. Prayer is allowed.

All above 15 accused persons are permitted to remain on the previous bail bond.

Rest 11 accused persons namely, 1. Narayan Hazra (CS Sl No.3), 2. Pulakesh Singh (CS Sl No.4), 3. Gobinda @ Rabindra Bhunia (CS Sl No.8), 4. Ratan Samanta (CS Sl No.9), 5. Sudhangshu Mahapatra (CS Sl No.17), 6. Bapi Singha (CS Sl No.18) , 7. Shaktipada Mondal (CS Sl No.19), 8. Ratan Bera (CS Sl No.22), 9. Haripada Jana (CS Sl No.23), 10. Haripada Bhunia (CS Sl No.26) and 11. Jugal Bera (CS Sl No.27) are absent by petition.

Sureties failed to produce the accused persons in spite of direction.

Issue W/A against accused CS Sl No. 3, 4, 5, 9, 17, 18, 19, 22, 23, 26, and 27.

Start proceeding under section 446 of CrPC against the sureties.

Fix **15.09.2023** for appearance and ER of W/A of accused CS Sl No. 3, 4, 5, 9, 17, 18, 19, 22, 23, 26, and 27.
