

Order No. 65, dated 17.12.2022

Today is fixed for E/R of W/P/A of accused Halim Laskar.

E/R of W/P/A of accused Halim Laskar is received from Basanti P.S. with a report that no movable property of the accused has been found and the accused is found absent at his residence.

Seen the nil seizure list.

It appears from report that the accused is concealing himself and at present he is not traceable.

The case against accused Halim Laskar be filed for present.

Accused Forej Laskar is produced from J/C.

Record shows that charge-sheet submitted against 07 accused persons. 05 accused persons, namely, Manab Kundu, Sambhu Kundu, Manas Chanda, Sariful Molla, Alaka Giri were granted bail by this Court on 01.11.2019.

It appears from record that the Hon'ble Court vide order dated 04.03.2021 passed in CRM No. 6550 of 2020 with CRAN 01 of 2020 has been pleased to set aside bail order dated 01.11.2019 in respect of accused Manab Kundu, Sambhu Kundu, Alaka Giri and Sariful Molla and directed them to surrender before this Court. The Hon'ble High Court at Calcutta has been pleased to confirm order for bail of accused Manas Chanda.

It appears from record that this Court received copy of order of the Hon'ble Apex Court passed in Special Leave Petition (Criminal) Diary No(s). 6602 of 2021. In that order the Hon'ble Apex Court has been pleased to pass the following order -

“Stay already granted with regard to surrender of the petitioners shall stand extended till 3rd May, 2021 or until further order whichever is earlier”.

This Court received further order of the Hon'ble Apex Court vide SCA Docket No. 2, dated 12.08.2022 and it appears from the order that the Hon'ble Apex Court has been pleased to pass the following order -

“the interim protection as granted in the earlier orders shall continue until the next date when the matter is considered by the Court”.

It appears from the order that the Hon'ble Apex Court stayed direction for surrender of the accused persons, Manab Kundu, Sambhu Kundu, Alaka Giri and Sariful Molla.

Accused Sariful Molla, Alaka Giri are present by filing hazira.

Accused Sambhu Kundu and Manab Kundu are absent by petition.

Accused Manas Chanda is present by filing hazira.

No further order is received from Hon'ble Apex Court.
