Accused person namely Akash Shaw has been produced under arrest along with forwarding report, arrest memo, inspection memo, check list, intimation of grounds of arrest, information to arrested person regarding particular of offence, record of emergency OPD and notice to the accused.

He is taken into custody and remanded to J.C till 07.03.2026

A petition praying for bail has been filed by Ld. Advocate for the accused person after serving copy to the Office of Ld. PP, Hooghly.

Ld. Advocate for the accused person is present along with Ld. PP-in-Charge, Hooghly.

Ld. Advocate on behalf of CESC Ltd. is also present and endorsed the bail application.

Now the bail petition is taken-up for hearing.

Ld. Advocate for the accused submits that the accused is ready and willing to pay 25% of the penalty amount as assessed by the CESC Ltd. He prays for bail of the accused person on any terms and conditions.

Heard Ld. PP-in-Charge who raises objection.

Ld. Advocate on behalf of CESC Ltd. also raised objection.

Perused the case record.

Considered the submissions of all sides.

As per the submissions advanced by Ld. Advocate for the accused, the accused person is directed to pay 25% of the penalty as assessed by the CESC Ltd. within a period of 7 (seven) days from the date of passing of this order and filing receipt before this Court. His bail prayer shall be considered after making payment of 25% of the penalty as assessed by the CESC.

Thus, prayer for bail in respect of accused namely Akash Shaw stands rejected.
