Matter is at the stage of PE/ furnishing of bail bonds by
accused persons namely Pooja and Suman Devi.

Bail bonds have been furnished on behalf of accused
persons namely Pooja and Suman Devi. **Let the same be verified through
SHO concerned on NDOH.**

Perusal of previous order reveals that initial assessment was
done before examining PW 1/victim 'R', as she is aged about 15 years
and she during initial assessment has submitted that her friend namely
Radhika has told her before the testimony '*agar nahi jaoge toh tumhare
maa baap ko jaan se maar denge*'. Thereafter, present file was placed
before Chairperson, Witness Protection Committee, West, THC, Delhi for
appropriate orders, as deemed fit, in view of the initial assessment done
of PW 1/victim 'R'.

No directions have been place before undersigned till the
present date of the witness protection committee.

PW-1/ Victim 'R' present before the court stands discharged
as unexamined for today.

Perusal of file reveals that there is only one victim in the
present case and the age of victim on the date of incident, was about 15

years. Furthermore, the said victim has deposed the abovementioned facts on the initial assessment by the undersigned. The accused persons are facing trial for the offences punishable u/s 137 (2)/ 140 (3) /127 (3) / 3(5) BNS.

At this stage, it is also taken note of that vide Gazette Notification No. F. No. 61(313)DD(CPU)/DWCD.2013/Vol-III/ 28784-816 dated 25.10.2018 of Department of Women and Child Development, Courts of Ld. ASJ-06 & 07, West, THC have been designated as special Courts in addition to Ld. ASJ-01 for trial of offences against children or of violation of child right for the NCT of Delhi. It appears that the victim in the present case is a child and the present offence is specifically triable by the aforesaid Designated Courts.

Ld. APP for the State has conceded to the jurisdiction of the designated Court in terms of the aforesaid Gazette Notification.

In view of the above observation, let the instant file be placed before the Ld. Principal District & Sessions Judge, West, THC, Delhi for appropriate order on this aspect.

Let copy of aforesaid Gazette Notification be also placed before Ld. Principal District & Sessions Judge, West, THC, Delhi for perusal.

Ahlmad is directed to place the file before Ld. Principal District & Sessions Judge, West, THC, Delhi on 22.07.2026 at 2 PM.

Accused Nikhil Maurya be produced before Ld. Principal District & Sessions Judge, West, THC on the aforesaid date.

All the parties are directed to appear before Ld. Principal District & Sessions Judge, West, THC, Delhi on the aforesaid date.
