

Matrimonial Suit No.407/2025

Sri Partha Sarathi Ghosh – Vs.- Smt. Kuheli Mondal (Ghosh)

Order No.03 dated 21/04/2026

Today is fixed for reconciliation and further order.

Both petitioner no. 1 and petitioner no. 2 are present in Court.

Ld. Advocates of both sides are also present.

Before taking up the matter this Court takes an endeavour to reconcile the dispute between the parties so that they may resume their conjugal life once again. However, the attempt of reconciliation fails.

The case is taken up for hearing.

Both sides filed their affidavit-in-chief. Petitioner No.1 and Petitioner No.2 are examined one after another.

Heard the Ld. Advocates for both the parties. Considered.

Now, the case is taken up for passing order.

This is a petition u/s 13B of the Hindu Marriage Act 1955 filed by the Petitioner No. 1 **Sri Partha Sarathi Ghosh** and Petitioner No. 2 **Smt. Kuheli Mondal (Ghosh)**, praying for dissolution of marriage by a decree of divorce.

Petitioners No. 1 & 2 have appeared today before this Court. The original petition u/s 13B of the Hindu Marriage Act, 1955 was filed on **04/09/2025**. The second motion is taken up on expiry of the statutory period of six months after the date of presentation of the petition referred above.

During enquiry it appears that the parties are living separately for a period of one year or more and they have not been able to live together and accordingly, have mutually agreed to dissolve the marriage.

This Court is satisfied that a marriage has been solemnized between the parties and the averments made in the petition are true for passing a decree of divorce declaring the marriage to be dissolved with effect from the date of decree.

Hence, it is

Ordered

That the suit be and the same is decreed on consent.

The marriage solemnized between the petitioners namely **Sri Partha Sarathi Ghosh** and **Smt. Kuheli Mondal (Ghosh)** on **31/07/2024** is dissolved by a decree of divorce **u/s 13B of Hindu Marriage Act, 1955**.

Decree be drawn accordingly.
