The instant application under section 483 of B.N.S.S filed by accused/petitioner namely, Sk. Amir Hossain @ Amirul, in connection with Jangipara P.S. Case No. 309/2025 dated 25.07.2025 under Section 310(4)/310(5) of B.N.S., is taken up for hearing.

Heard the Ld. Advocate for the petitioner/accused, who submitted that no application under section 483 of B.N.S.S. in respect of this petitioner/accused has been rejected or is pending before any higher court of law. Ld. Advocate further submitted that this is a case under sections 310(4)/310(5) of B.N.S. The petitioner/accused is in custody since 19.02.2026. Moreover, he is not named in the F.I.R and also nothing has been seized from him. The co-accused persons are on bail and also charge-sheet has already been filed in this case. He prays for bail of the petitioner/accused on any condition.

Ld. P.P.-in-charge opposed the prayer for bail.

Perused the application under section 483 of B.N.S.S., L.C.R. and C.D.

It transpires from the F.I.R. that this is a case under sections 310(4)/310(5) of B.N.S. It also transpires from record that the petitioner/accused was brought under arrest in connection with this case on 19.02.2026. It also transpires that he is not named in the F.I.R and also nothing has been seized from him. Moreover, the co-accused persons are on bail and also charge-sheet has already been filed in this case.

Considering all aspect, I am inclined to allow the prayer for bail of the petitioner/accused namely, Sk. Amir Hossain @ Amirul. Hence, prayer for bail of the petitioner/accused is allowed.

Accordingly, the petitioner/accused namely, Sk. Amir Hossain @ Amirul, may find bail of Rs. 4,000/- with two sureties of Rs. 2,000/- each, subject to the satisfaction of the Ld. A.C.J.M., Serampore, on condition that he shall appear before the court on all the subsequent dates fixed.

Instant criminal misc. case is, thus, disposed of. Return L.C.R. and C.D.

Let a copy of this order be sent to the Ld. A.C.J.M., Serampore for information and taking necessary action.

Let a soft copy of this order be sent to the Superintendent of concerned Correctional Home for due intimation of his bail to the petitioner.
