Ld. Accused on behalf of the accused Anand Kahar @ Guddu submits before this court that accused Anand Kahar is in J.C. since last one month in connection with the instant case. There is no chance of his abscondence or otherwise evading the due process of law. Ld. Adv. for the accused prays for bail.

I have gone through the case record. On perusal of case record it appears that during trial when the evidence of 4 prosecution witnesses have already been recorded. At this stage, the warrant of arrest against the accused Pawan Gupta and Anand Gupta was issued. Moreover, the W.A. against the accused Pawan Gupta is still pending for execution.

Considering the situation, I am not inclined to release the accused persons on bail at this stage. Accordingly, his prayer for bail is considered and rejected.

The O.C. of Rishra P.S. is directed to execute the E.A. pending against the accused Pawan Gupta positively on the date fixed.
