Deposition of witness No. **PW- 01** for the prosecution recorded on oath or solemn affirmation under provision of OATHS ACT, 1969 (Act, 44 of 1969) on this 8th day of June, 2023 in the English language interpreted by me.

Name- **SI Arjan Chakma**, S/O Lt. Bir Sahodar Chakma, age of 38 years, Presently posted at Sabroom PS, Police Station- Sabroom, District- South Tripura, Occupation- Govt. employee, Hindu, Literate.

Examination-in-chief:-

Since 26.03.2022, I was posted at Sabroom PS. On 09.04.2022 at about 08:20pm, we received an information from some secret source that at Mahendra nath tilla under Sabroom Nagar Panchayet, one person namely, Sri Abhijit Dey @ Bhutan was selling some contraband drugs in small container from his shop which is adjacent to his residence. After receiving such telephonic information, relevant GD Entry no. 24 dated 09.04.2022 was entered and we intimated the matter to SDPO, Sabroom and Supdt. of Police, South Tripura. Then, on receiving the the authorization letter from the SDPO, Saboom I accompanied by the then SDPO Sri Salpa Kr. Jamatia, The then O/C of Sabroom PS Insp. Sanjay Laskar and other 6-7 associate police personnel including W/c Sanju Nama, proceeded to the shop of Sri Abhijit Dey @ Bhutan to conduct raid, wherein we found one plastic bag having 120nos. Plastic containers containing suspected contraband articles/ drugs in his shop. Accordingly, I seized those plastic containers after taking the measurement of such containers containing the contraband articles, in presence of the then SDPO, Sabroom and prepared the seizure list dated 09.04.2022 in which the then SDPO put his signature as seizure witness along with other independant witnesses. The net weight of those 120nos. Of plastic container containing suspected drugs, recovered from the possession of Sri Abhijit Dey @ Bhutan was 51.85 grams. These are the seizure

lists dated 09.04.2022 in c/w Sabroom PS GD no. 24 dated 09.04.2022, prepared by me in my own hand writing, on identification to be marked as **Exbt.1 and 1/1** respectively. These are my signatures on the seizure lists dated 09.04.2022, on identification to be marked as **Exbt.1a and 1a/1** respectively. Thereafter, I lodged the suo-moto FIR against Sri Abhijit Dey @ Bhutan. The written ejahar was typed by me. This is the written suo-moto FIR lodged by me and this is my signature thereon identification to be marked as **Exbt.2 and 2/1** respectively. I did not collect any representative sample, as the IO collected the same in presence of Ld. Court during investigation. The seized contraband articles were kept in PS malkhana, with reference to no. 10 of 2022.
