CHARGES WITH THREE HEADS

[No. XXVIII (II), SCHEDULE V, Act V, 1998]

(Sections 221, 222, 223, Code of Criminal Procedure)

(1) Name and office of Magistrate, & etc. I,<sup>(1)</sup> Md. Ehteshamuddin, Additional Sessions Judge, Fast Track Court, Serampore, hereby charge you<sup>(2)</sup>

(2) Name of accused persons as follows: 1. **Sk. Motibul**, 2. **Shila Begum** and 3. **Sk. Peskar**

**Firstly** – that you in furtherance of common intention, since the marriage with the complainant and you being the husband and relatives of the husband subjected her namely, Mst. Esratun Khatun to cruelty by inflicting torture upon her both mentally and physically and that you thereby committed an offence punishable u/s **498A/34** of Indian Penal Code and within the cognizance of this Court of Sessions.

(3) My cognizance or the cognizance of the Court of Session. **Secondly** – that you, in furtherance of common intention of all, after marriage of Mst. Esratun Khatun, being entrusted with stridhan property of Mst. Esratun Khatun and you have misappropriated those stridhan articles which were given to Mst. Esratun Khatun

and that you thereby committed an offence punishable u/s **406/34 of the I.P.C.** and within the cognizance of this Court of Session.

**Thirdly** - *That you, after the marriage of Mst. Esratun Khatun then being with child to miscarry without her consent and such miscarriage was not being caused by you in good faith, by giving her some herbal medicine and due to such act by you her child in womb has been killed*

(4) In cases tried by Magistrate, omit “by the said Court.”

and that you thereby committed an offence punishable u/s **313/34** of Indian Penal Code and within the cognizance of this Court of Sessions.

And I hereby direct that you be tried by this Court on the said charge. The charge being read over and explained to them, the accused persons pleaded not guilty by saying “Ami nirdosh” and claim to be tried.

(Sections 221, 222, 223, Code of Criminal Procedure)

(1) Name and office of Magistrate, & etc. I,<sup>(1)</sup> Md. Ehteshamuddin, Additional Sessions Judge, Fast Track Court, Serampore, hereby charge you<sup>(2)</sup>

(2) Name of accused person as follows: **1. Sk. Peskar**

**Firstly** – that you, after the marriage of Mst. Esratun Khatun, assaulted/used criminal force to the victim with the intention of disrobing or compelling her to be naked

and that you thereby committed an offence punishable **u/s 354B** of Indian Penal Code and within the cognizance of this Court of Session

(4) In cases tried by Magistrate, omit “by the said Court.” And I hereby direct that you be tried by this Court on the said charge.

On the charge being read over and explained to him, the accused person pleaded not guilty by saying “Ami nirdosh” and claim to be tried.
