CHARGES WITH FOUR HEADS

[No. XXVIII (II), SCHEDULE V, Act V, 1998]

(Sections 221, 222, 223, Code of Criminal Procedure)

(1) Name and office of Magistrate, & etc. I,⁽¹⁾ Md. Ehteshamuddin, Additional District & Sessions Judge, Fast Track Court, Serampore, Hooghly, hereby charge you⁽²⁾

(2) Name of accused person as follows: Anit Chakraborty S/o late Ashu Ranjan Chakraborty of 49/A/A GT Road, Rishra, P.S Rishra Dist. Hooghly.

Firstly – that you on 29.02.2020 at about 12.00 hours wrongfully restrained Sangita Das Mondal in your house

(3) My cognizance or the cognizance of the Court of Session. and that you thereby committed an offence punishable u/s **341** of Indian Penal Code, and within the cognizance of this Court of Sessions.⁽³⁾

Secondly – that you on 29.02.2020 at about 12.00 hours voluntarily caused hurt to Sangita Das Mondal in your house

and that you thereby committed an offence punishable u/s **323** of the Indian Penal Code, and within the cognizance of this Court of Sessions.⁽³⁾

Thirdly - that you on or about 12.02.2020 by dishonestly inducing her on the assurance of false marriage to consent to have sexual intercourse with him which she would not do if she were not so deceived

and that you thereby committed an offence punishable under Section **417** of Indian Penal Code, and within my cognizance

Fourthly – that you have committed rape upon her several times on the assurance of false marriage at the rented house at Rishra

and that you thereby committed an offence punishable under Section **376** of Indian Penal Code, and within my cognizance

(4) In cases tried by Magistrate, omit “by the said Court.” And I hereby direct that you be tried⁽⁴⁾ by this Court on the said charge. On the charge being read over and explained to them, the accused persons individually pleaded not guilty by saying “Ami nirdosh” and claimed to be tried.
