(1) Name and office of Magistrate, & etc.	I, Sri Nayyar Azam Khan, Additional District & Sessions Judge, 2nd Court, Serampore hereby charge you
(2) Name of accused person	Sukhendu Koley, Smt. Uttara Koley and Smt. Bhaswati Koley
	Firstly, that you, on 13.03.2022 in the morning at Raghunathpur (Kolepara), P.S. Dankuni, Dist. Hooghly, in furtherance of your common intention, wrongfully restrained the complainant Chandana Roy and her daughter Monjistha Roy and that you thereby committed an offence punishable under Section 341 of the Indian Penal Code read with Section 34 of IPC and within my cognizance.
	Secondly, that you, on 13.03.2022 in the morning at Raghunathpur (Kolepara), P.S Dankuni, Dist. Hooghly, in furtherance of your common intention, caused hurt to Chandana Roy by assaulting her with kicks, fists and blows and that you thereby committed an offence punishable under Section 323 of the Indian Penal Code read with Section 34 of IPC and within the jurisdiction of this Court.
	Thirdly, that you, on 13.03.2022 in the morning at Raghunathpur (Kolepara), P.S Dankuni, Dist.Hooghly, in furtherance of your common intention, threatened to kill the daughter of complainant namely Monjistha Koley and thus you thereby committed the offence punishable u/s 506 of the Indian Penal Code read with Sec. 34 of the I.P.C.
	And I hereby direct that you be tried by this Court on the said charge. On the charge being read over and explained separately to the accused persons in Bengali the accused persons individually pleaded not guilty by saying " Ami Nirdosh " and claimed to be tried.

(1) Name and office of Magistrate, & etc.	I, Sri Nayyar Azam Khan, Additional District & Sessions Judge, 2nd Court, Serampore hereby charge you
(2) Name of accused person	Sukhendu Koley
	Firstly, that you, on 13.03.2022 in the morning at Raghunathpur (Kolepara), P.S Dankuni, Dist. Hooghly assaulted Chandana Roy with a tob with such intention or knowledge and under such circumstances that if by that act you would have caused death of Chandana Roy, you would have been guilty of murder and thus you thereby committed the offence punishable u/s 307 of the Indian Penal Code.
	Secondly that you, before 13.03.2022 at Raghunathpur (Kolepara), P.S Dankuni, Dist. Hooghly cheated Monojit Roy by dishonestly inducing him to deliver Rs.4,62,500/- to you for business purpose as per agreement between yourselves on a non-judicial stamp paper of Rs.10/- but you did not return the said amount and that you thereby committed an offence punishable under Section 420 of the Indian Penal Code and within my cognizance.
	And I hereby direct that you be tried by this Court on the said charge. On the charge being read over and explained to the accused person in Bengali the accused person pleaded not guilty by saying " Ami Nirdosh " and claimed to be tried.

Heard both sides and found that the materials on record and the existing evidence suggest to frame the charge against the accused persons namely Sukendu Koley, Uttara Koley and Bhaswati Koley for the offences punishable u/s 341/323/506 read with Sec. 34 of I.P.C and additionally against accused Sukendu Koley for the offences punishable u/s 307/420 I.P.C. The substance of accusation for the respective offences is read over and explained to the respective accused persons to which they separately pleaded not guilty by saying "আমি নির্দোষ" and claimed to be tried.

Formal charge has been framed separately in detail on separate sheet.
