JUDGMENT ON ADMISSION

The accused no. 1 and 2 is appeared before the court. They have ready to admit their guilt voluntarily. They have submitted that they are karta of their family. Their economic condition is poor. Therefore, prayed for imposing minimum fine amount and imprisonment. Considering the submission and nature of the case it will proper to give the leniency to the accused while awarding punishment. Hence, order:

- ORDER -

1. Accused no.1 and 2 are hereby convicted for the offence punishable under Section 12-A of the Maharashtra Prevention of Gambling Act vide Section 275 of Bhartiya Nagrik Suraksha Sanhita, 2023.
2. Accused no.1 and 2 are sentenced to imprisonment till rising of the Court and shall pay fine of Rs. 300/- (Rupees Three Hundred only) **each** in default to suffer simple imprisonment for 10 days.

3. Seized muddemal cash Rs. 5,390/- be credited to the government after appeal period is over.
4. The property seized one peacock green color mobile phone of VIVO company, model V21 IMEI no. 863935056565610 be sold in auction and proceed received from auction be credited to the government.
5. The seized muddemal property one book bearing the name 'Sridevi', containing a piece of carbon paper and one boll pen be destroyed after appeal period is over.
