The complaint appears to be well within the limitation period. Upon consideration of the complaint, documents filed and examination of complainant, prima facie there appears to be sufficient ground to proceed against the accused u/s. 138 N.I. Act. I hereby take cognizance of the offence punishable u/s. 138 of Negotiable Instruments Act, 1881.

Let the accused be summoned on filing of PF and the META Data form within 15 days through RC-AD, Speed Post/approved courier services and Whatsapp/Email returnable on the NDOH.

Endorsement be made to the effect that offence punishable under section 138 of the Negotiable Instruments Act, 1881 is compoundable by virtue of section 147 thereof, and should the Accused disburse/deposit the cheque amount on or before the first date of hearing, the complaint may be compounded in terms of ratio of judgment in the case of **Damodar S. Prabhu Vs. Sayed Babalal H. (2010) 5 SCC 663.**
