CHARGE WITH SEVEN HEADS
{No. XXVIII(II) Schedule V. Act V, 1898}
(Sections 221, 222, 223 Code of Criminal Procedure)

I, do hereby charge you : 1) Bapan @ Subhajit Singha, 2) Bapi @ Ajoy Ghosh,
3) Salil Majumder & 4) Babi @ Abhijit Barui.

as follows :- **Firstly**, that you on 22.01.2018 at about 7 pm at Kadamtala Pathsala More, P.S. Bantra, Dist. - Howrah, wrongfully restrained Debnath Das with common intention and that you there by committed an offence punishable u/s 341/34 of the IPC and within the cognizance of this court.

And I do hereby direct that you be tried on the said charge.

Secondly, that you at the above said date, time and place voluntarily caused hurt to said Debnath Das with common intention and that you thereby committed an offence punishable u/s 323/34 of the IPC and within the cognizance of this court.

And I do hereby direct that you be tried on the said charge.

Thirdly, that you at the above said date, time and place voluntarily caused grievous hurt to said Debnath Das with common intention and that you thereby committed an offence punishable u/s 325/34 of the IPC and within the cognizance of this court.

And I do hereby direct that you be tried on the said charge.

Fourthly, that you at the above said date, time and place voluntarily caused grievous hurt to said Debnath Das by killing him with butt of a gun with common intention and that you thereby committed an offence punishable u/s 326/34 of the IPC and within the cognizance of this court.

And I do hereby direct that you be tried on the said charge.

Fifthly, that you at the above said date, time and place was trying to kill the said Debnath Das with butt of a gun under such circumstances that if by that act you all had caused the death of said Debnath Das with common intention and that you thereby committed an offence punishable u/s 307/34 of the IPC and within the cognizance of this court.

And I do hereby direct that you be tried on the said charge.

Sixthly, that you at the above said date, time and place intending to insult the modesty of Alpana Das assaulted/used criminal force to Alpana Das with the intention of disrobing or compelling her to be naked with common intention and that you thereby committed an offence punishable u/s 354B/34 of the IPC and within the cognizance of this court.

And I do hereby direct that you be tried on the said charge.

Seventhly, that you at the above said date, time and place assaulted/used criminal force to Alpana Das with the intention of disrobing or compelling her to be naked with common intention and that you thereby committed an offence punishable u/s 509/34 of the IPC and within the cognizance of this court.

And I do hereby direct that you be tried on the said charge.

The contents of the charges so framed are read over and explained to the accused persons in Bengali Language to which they plead not guilty and claim to be tried.
