ORDER OF CONVICTION ON PLEA GUILTY

- 1) The accused appeared before me. The accused is facing prosecution of the offence punishable under Section 283 of Indian Penal Code.
- 2) The accused person voluntarily pleaded guilty for the alleged offence. Therefore, I hold guilty to accused for an offence as above mentioned. Here, I pause a while to hear accused on the point of sentence.
- 3) The punishment provided for aforesaid offence is only fine upto Rs.200/-. Accused is ready to pay the fine. Accused submitted that he is not deliberately parking his vehicle in the middle of road. Considering voluntariness of accused I hold guilty to accused for the offence punishable under section 283 of I.P.C. and proceed to pass following order.

ORDER

1. The accused is hereby convicted for the offence punishable under section **283** of the Indian Penal Code, vide section **252** of the Code of Criminal Procedure.
2. The accused sentenced to pay fine of **Rs.200/- (Two hundred rupees only)** in default, the accused shall suffer simple imprisonment for 07 (seven) days.
