Accused Subodh Pramanik is produced from J.C.

A bail petition is filed on his behalf with one death certificate and the Ld. Advocate of the accused submits that the mother of the accused had died on 12.06.2016 and for her 'sradh' ceremony the accused may be granted bail.

Ld. Spl. P. P raised objection and submits that more than commercial quantity of opium has been recovered from the house of the accused and from his possession, so, the accused should not be granted bail.

Perused the materials on record. Considering the seizure of 2.75 kgs of ganja from the accused, I am not inclined to allow the bail application and the same is rejected.

Considering the fact that the accused wants to discharge his duty of his mother's 'sradh' ceremony, the accused Subodh Pramanik is granted release on parole for four (04) days from 24.06.2016 to 27.06.2016.

The Superintendent of District Correctional Home, Howrah is directed to make necessary arrangement to that effect and to produce the accused Subodh Pramanik on 28.06.2016.
