

WITNESS CALLED AND DULY SWORN ON 10.03.2026.**CROSS EXAMINATION BY SRI.S.V., ADVOCATE FOR THE RESPONDENT:-**

1. My DOB is 01-07-1985 and place is Jemshedpur. I am BDS graduate and completed MBA. On 10-06-2025 Petitioner was employed me. My hospital has not authorized anybody to handover blank letter heads to the stranger. We have not authorized any person to handover blank letter heads to distribute to strangers.

2. I have gone through the original petition, amended petition and documents. I have not gone through the objections filed by the Respondents. It is true to suggest that, the original petition filed by Mr.P.Nithyananda. It is false to suggest that, there was no board resolution to file this petition by giving authorization to Mr.P.Nithyananda. I do not have any difficulty to produce the board resolution authorized to Mr.P.Nithyananda. I have not personally seen board resolution to authorize Mr.P.Nithyananda.

3. It is true to suggest that, the amended petition was filed by Mr.Ratheef K.M. I am not sure about there was no board resolution for filing amended petition by Mr.Ratheef K.M. I am able to check and produce the board resolution authorized to Mr.Ratheef K.M. I have never seen board resolution authorized to Mr.Ratheef K.M.

4. I do not have any difficulty to produce original board resolution issued and authorized Mr.Anshuman Jaiswal. It is false to suggest that, there is no board resolution to authorize Mr.Anshuman

Jaiswal. It is false to suggest that, I do not have any authority to represent in the petition. Mr.Anshuman Jaiswal have issued authority to represent in this petition.

5. It is false to suggest that, Ex.P.1 is not the electronic record. I do not have any difficulty to produce notice dtd.21.04.2023. I have seen postal receipt and postal acknowledgment of the above notice. I do not have any difficulty to produce postal receipt and postal acknowledgment before the Court. It is false to suggest that, the petitioner not sent any notice to the Respondent on 21.04.2023.

6. I have not personally visited the Respondent's clinic between 20.04.2023 and 29.05.2023. I have seen photographs of building, screenshots of website in the month of November-2025 and I came to know about the disobedience of the order. I came to know about the disobedience through Respondent's own website, Justdial and Practo.

7. I have not taken the screenshot marked as Ex.P.3. I am not aware who has taken the screenshot marked as Ex.P.3. It is very difficult to identify the person appears top right side of Ex.P.3. The screenshot Ex.P.3 have been available in the Laptop which has given by our company to me.

8. My employees are not authorized to use Bookmarked websites Disney hotstar, You-tube, Whatsapp, Facebook, Instagram and Primevideo in the office hours. I am not sure that, any body of our employee was not taken screenshot marked as Ex.P.3.

9. It is true to suggest that, the Respondents does not have control over websites like Justdial, Practo and Timesmed. I am not sure about the information about the order passed by this court on 20.04.2023 to the above referred websites. I do not have any difficulty to get information from above websites whether the petitioner has intimated about the order.

10. I have not verified the ownership of website rainbow-health-care.business.site and rainbowhealthcareblr.in. It is okay that, the Respondent does not own rainbow-health-care.business.site. I am not sure that, rainbowhealthcareblr.in was deactivated before filing of this petition. It is false to suggest that, the documents produced from rainbow-health-care.business.site is fabricated document. Witness volunteers I joined the company in the month of June-2025. Therefore, I know about the documents available in my company Laptop.

11. Deepak Kumar was the Private Investigator hired by Petitioner. I am unable to provide address and details of Deepak Kumar. We do not have any difficulty to examine Deepak Kumar in the present case. I do not have any difficulty to produce the Investigation report investigated by Deepak Kumar. I am not sure to produce the original prescription and prescription folder of Respondent before the court. I can produce original invoice before the court as referred in examination-in-chief of para No.7. I am not sure to produce original vaccination before the court.

12. Ex.P.7 to 12 photographs have been taken by our company's ex-employee Arun. It is true to suggest that, the photographs marked as Ex.P.7 to 12 are not captured through the device mentioned in Ex.P.8, 10 and 12. I am not sure about on which device the photographs were captured. It is false to suggest that, Ex.P.7 to 12 are fabricated for the purpose of this petition. I am not sure that, Ex.P.7 to 12 photographs were captured using an app called 'GPS Map camera'. I do not have any difficulty to examine Mr.Arun before the court. It is false to suggest that, 'GPS Map camera' app is a malfunctioning app. It is false to suggest that, the Respondent has always complied the order passed by this court on dtd.20.04.2023. It is false to suggest that, the petitioner has fabricated the documents to harass the Respondents.
