Order No.03 dated 22.06.2026.

The application u/S.482 BNSS arising out of Shibpur P.S. Case No. 175 of 2026 dated 30.04.2026 u/Ss. 316(2)/318(4)/303(2)/336(3)/338/3(5) of BNS, filed by the accused/petitioner namely, Mrs. Paramita Chatterjee, is taken up for hearing.

The petitioner has stated on affidavit that no application has been pending or rejected before or by the Hon'ble High Court till date.

Perused the petition and the C.D. Heard both sides.

Ld. Advocate appearing for the petitioner submitted that the petitioner has been called for interrogation by Shibpur PS after the instant FIR was lodged at Shibpur PS and she all along cooperated with the investigation and despite the said fact she has been called by the I.O of CID to face interrogation after the investigation of the case has been handed over to the CID and it is prayed to allow the prayer for anticipatory bail.

I.O is present in person with the CD and it is submitted by him that notice has been served upon the petitioner through the local PS where the petitioner is residing though no receipt copy of the notice is lying with him.

Ld. P.P appearing for the State submitted that till date the petitioner is not implicated in this case and it is appearing from the statement lying in the CD that at the relevant point of time she was worked with the organization as store Manager.

Ld. Advocate appearing for the de facto complainant submitted that the petitioner is not implicated in this case till now though the investigation is in progress and another PS case has been initiated at Serampore PS where one Subir Biswas is an FIR named accused and the present petitioner has connection with said Subir Biswas.

On perusal of the record it appears that this case relates to the alleged offence punishable u/Ss. 316(2)/318(4)/303(2)/336(3)/338/ 3(5) of BNS, and it appears from the FIR that one Gautam Das authorized legal counsel/ General Manager of Ulike Stock & Securities Pvt. Ltd., with jewelery showroom under the brand name Tanishq lodged the same against one Soumyajit Das who is an employee of Tanishq showroom, Howrah on the allegations of illegally removing gold ornaments from the vault of the company received under gold exchange scheme by practicing fraud along with various other allegations.

On perusal of the materials lying in the C.D., it appears to me that the investigation is in progress and the present petitioner was interrogated in connection with this case and till now no implication has been suggested against her and in my view the application for anticipatory bail is premature and it is rejected accordingly.

C.D and T.C.R be returned.

The Cr. Misc. Case is thus disposed of.
