An application has been filed on behalf of the accused persons, namely Salman Molla and Gora Khan along with server copy of an order dated 13-02-2025 passed by the Hon'ble Court in CRM (N.D.P.S) 20 of 2025 along with a fresh vokalatnama and an affidavit by the Ld. Counsel Sajis Halder, affirming the genuinity of the said order. It is prayed on behalf of accused persons Salman Molla and Gora Khan to allow the accused persons to furnish the bond as directed by the Hon'ble High Court.

Ld. Advocate on behalf of the said accused persons have also stated in his letter head that the server copy of order of the Hon'ble High Court is a genuine one.

Perused the application.

Heard. It appears that the Hon'ble High Court has been pleased to make the following observation:

"...4. Accordingly, we direct that the petitioners, namely, Salman Molla and Gora Khan, shall be released on bail upon furnishing a bond of Rs.25,000/- (Rupees Twenty Five Thousand) each, with two sureties of Rs.12,500/- each, one of whom must be local, to the satisfaction of learned Judge, Special Court under N.D.P.S Act cum Additional Sessions Judge, 3rd Court, Howrah. The petitioners shall appear before the learned trial Court on every date of hearing and shall not intimidate the witnesses and/or tamper with evidence in any manner whatsoever and/or commit any cognizable offence in any manner whatsoever. The petitioners shall remain within the jurisdiction of Howrah Police Station except for the purpose of attending the court proceedings and shall report to the Officer-in-Charge/Inspector-in-Charge of Howrah Police Station once in a fortnight, until further orders. The petitioners shall, through their learned counsel, inform the learned trial Court, Sankrail Police Station and Howrah Police Station, their current local address at Howrah where they shall be residing while on bail.

5. In the event the petitioners fail to comply with any of the conditions stipulated above, the trial Court shall be at liberty to cancel the bail in accordance with law without further reference to this Court..... "

It is manifest from the record that the Hon'ble High Court has been pleased to grant bail to the accused persons and they have filed an application intending to furnish bail bond in terms of the order passed by the Hon'ble High Court.

The prayer is considered and allowed in view of the order of the Hon'ble High Court. The accused persons are at liberty to furnish a bond, as it has been stipulated by the Hon'ble High Court, accordingly.

Kabita Samanta and Rashmani Mondal appear before the Court and file two registered gift deeds separately being no. 050600021 of 2025, dated 06-01-2025 and 050605395 of 2024, dated 27-12-2024 along with photocopy of record of rights as local security of accused Salman Molla and Gora Khan. The said Kabita Samanta and Rashmani Mondal also file two affidavits separately affirming the genuinity of the said deed. The said Kabita Samanta and Rashmani Mondal also file bail bonds as local security on behalf of accused Salman Molla and Gora Khan.

Bablu Bhattacharjee and Sarbani Prasad Chatterjee file bond on behalf of the accused persons namely Salman Molla and Gora Khan as registered sureties. The said bail bonds appear to have been duly checked and fitted by the bail bond officer.

Perused the same, as well as other materials on record.

The bail bonds by the local sureties namely Kabita Samanta and Rashmani Mondal, depositing registered deed No. 050600021 of 2025, dated 06-01-2025 and 050605395 of 2024, dated 27-12-2024, both of ADSR Bagnan, Howrah are found sufficient and hence accepted.

It appears that the bail bonds filed by two registered sureties Bablu Bhattacharjee and Sarbani Prasad Chatterjee have been checked and fitted by the bail bond officer and hence the said bonds are accepted as well.

The said accused persons namely Salman Molla and Gora Khan appear to have satisfied this Court regarding the bail bond that the Hon'ble High Court has directed them to furnish before this Court in CRM (NDPS) 20 of 2025. As such, release them at once.

Issue release order in respect of accused persons namely Salman Molla and Gora Khan, directing the correctional home authorities to forthwith release the accused persons from custody, if they are not wanted in any other case or cases.
