

**BA 1728 of 2019 Sudesh Kumari alias Sudesh Rani Vs State of Punjab
CNR.No. PBGD01-006707-2019**

1. Present bail application has been filed under Section 438 Cr. P.C on behalf of accused/applicant Sudesh Kumari alias Sudesh Rani for grant of anticipatory bail in case FIR NO.38 dated 18.6.2019 under Sections 323,324,148,149,326 IPC, registered at P.S. Purana Shalla.
2. Allegations are that Harbans Lal complainant got recorded his statement before the police to the effect that he is owning one and half killa of land which has been taken by him on 'Batai' from Gurnam Singh son of Sujana Singh. This property falls within the area of village Bhaini Milma. On 15.6.2019, he alongwith his wife Raj Kumari went to for a round in his land and to say to Gurnam Singh to irrigate the crop. At about 6.30 P.M, Tarsem Singh son of Bhagat Ram armed with datar, his wife Sudesh Kumari and 3-4 unidentified persons came in their land on New Holland Tractor and they started cultivating their land. When he stopped from doing so, then Tarsem Singh attacked him with his datar and he raised his left hand and the datar hit on his left arm little blow the elbow. Thereafter he attacked with his datar from its reverse side which hit him in the middle of his head and the third attack given by him on the wrist of his right arm. He gave alarm and his wife Raj Kumari and Lakhwinder Singh saw the

occurrence and the assailants ran away from the spot. With these allegations, FIR in question was registered against applicants/accused and others.

3. Upon notice, Shri S.S.Virdhi Ld. Addl.P.P has appeared on behalf of the State.
4. Record has been called.
5. Arguments heard.
6. Contention of Sh.S.S.Saini, Adv, Ld. Counsel for applicant/accused is that applicant/accused has been falsely implicated in the present case. Contention is that no injury is attributed to applicant/accused. His contention is that injury has been self inflicted and MLR has been procured. It has been further argued that even an application was moved by husband of complainant to SSP, regarding their false implication and even the application was moved to Civil Surgeon, Gurdaspur for conducting medico legal report from the board of Doctors but injured failed to appear before the Board. Nothing is to be recovered from applicant/accused. Applicant/accused is a lady and she is ready to join investigation and co operate with the Investigating Agency.
7. Adjourned to 16.7.2019
8. In the meantime applicant/accused is directed to join investigation and cooperate with the IO. In the event of arrest of applicant/accused, she is ordered to be released on interim bail on her furnishing bail bonds and surety bonds to the

satisfaction of IO/Arresting Officer, subject to conditions laid down Under Section 438(2) Cr.P.C.

9. Compliance is awaited.
