Suit Claim: This is a suit filed by the plaintiff against the defendant for a sum of Rs.49,353/- together with current interest at the rate of Rs. 13.75 percent per annum from the date of suit till the date of realization with the court costs and other reliefs.

This petition coming on this the 7th day of November 2019 for final disposal before **Sri.K.M.Basavarajappa, B.Com., LL.B.,** Senior Civil Judge & JMFC., K.R.Nagara in the Presence of **Sri.K.C.S,** Advocate for Plaintiff and **Sri.G.S.L.,** Advocate for Defendant No.3, Defendant No-1 & 2-Exparte.

By pronouncing the Judgement, the suit of the Plaintiff is hereby partly decreed with costs.

The defendants No.1 to 3 are jointly and severally liable to pay the loan amount of Rs.75,000/- with interest at the rate of 9% p.a, from the date of decree till realization of entire claim. The defendant No.1 and 2 are liable to pay the said amount to the extent of estate of deceased Puneeth.

It is further made clear that defendant No.1 and 2 are not personally liable to repay the decretal amount.

It is further ordered and decreed that the defendant is directed to pay Rs.6426/- to the plaintiff the cost of the suit
