ORDER

1. This order of mine shall dispose of an application moved under Section 483 BNSS for grant of regular bail, on behalf of above

said applicants/accused.

2. The present case has been registered against the applicants/accused on the basis of the statement of complainant Satwinder Kaur on the allegations that on 26.09.2020 at about 11.30 A.M in the area of police station Bholath, the applicants/accused in furtherance of common intention had forcibly snatched ear rings from the ears of Ranjit Kaur and Satwinder Kaur after making preparation for causing hurt to them.

3. Upon notice, learned Public Prosecutor appeared and opposed this bail application. Court record was also called.

4. I have heard learned counsel for applicants/accused, learned Public Prosecutor for State and have gone through the record pertaining to this case very carefully, with their able assistance.

5. Record reveals that earlier the challan against the applicants/accused was presented before this court on 16.02.2021 and even they were charge sheeted vide order dated 19.02.2021 and thereafter the case was fixed for the evidence of the prosecution. Thereafter during the pendency of the case, both the applicants absented from the court on 16.12.2021 without any intimation and as such their bail order was cancelled and their bail bonds/surety bonds were also cancelled and forfeited to the State and they were ordered to be summoned through non-bailable warrants. Thereafter the present applicants themselves surrendered before the court on 09.08.2024 and since then they are in custody. The learned Public Prosecutor submitted that the applicants-accused have no respect for

law, so his bail application be dismissed, whereas on the other hand the learned counsel for the applicants-accused submitted that the applicants-accused are in custody since 09.08.2024 and they must have learnt a lesson for remaining absent from Court proceedings. The present applicants themselves have surrendered before the court and now the case is fixed for the evidence of the prosecution. The trial of case will take some more time and no purpose would be served by retaining the applicants-accused behind the bars for indefinite period. Otherwise also, the applicants-accused are not required for interrogation or recovery purposes. As such, the accused/applicants Jasbir Singh @ Rempi @ Shera and Sonu @ Monu are ordered to be released on bail, on their furnishing personal bonds in the sum of Rs.40,000/- with one surety of the like amount each to the satisfaction of this court. Bail application stands allowed accordingly. Bail bonds not furnished. Bail application be attached with the main file.
