Today is fixed for appearance of the accused person and evidence of P.W-1 Smt. Luna Das i.d. personal appearance of the Inspector-in-Charge of Shibpur P.S with written explanation.

P.W-1 is produced under arrest along with the arrest-cum-inspection memo, forwarding report, copy of the order of this Court, medical document and one another document. Let those be kept with the case record.

Ld. Advocate Sri Akash Pandit enters his appearance in this case representing P.W-1 by filing a vokatatnama. Let the same be kept with the case record.

At this stage, one bail petition is filed on behalf of P.W-1 on the ground stated therein.

Sole accused person on C.B is absent by filing a petition u/s 317 Cr.P.C with a prayer for allowing him to be represented through his Ld. Advocate.

Ld. PP-in-Charge is present.

Ld. Advocate for the accused persons is present.

Now, the petition under section 317 Cr.P.C is taken up for hearing.

Heard. Considered.

The petition u/s 317 Cr.P.C is hereby allowed subject to the condition that the accused/ petitioner shall not challenge his identity at any stage of trial.

Now, the case record is taken up for evidence.

P.W-1 is further cross-examined in part.

At this stage, Ld. Advocate for the accused person files a petition praying for time on the ground stated therein.

Heard. Considered. Prayer for time is hereby allowed.

Now, the bail petition is taken up for hearing.

Ld. Advocate representing P.W-1 submits that owing miscommunication and her physical inability, P.W-1 could not appear before this Court to depose his evidence. It was an unintentional laches. Accordingly, he prays for enlarging P.W-1 on bail.

Heard. Considered.

On perusal of the case record, owing to non-appearance of P.W-1 to conclude her evidence, this case was getting delayed and accordingly, this Court had issuedailable warrant against P.W-1.

At this stage, Ld. Advocate for P.W-1 submits that she is very poor and does not have sufficient means.

Considering the above facts and circumstances and pending part cross-examination, let PW-1 be released at once on condition that she will attend this Court for facing further cross-examination on the next date fixed positively.

Thus, the bail petition is disposed of.
