ORDER :-

This order shall dispose of bail application U/s 439 Cr.P.C filed by applicants/accused Baljeet Singh, in the above noted case.

2. Upon notice, learned Addl.P.P for the State appeared, but no reply has been filed.

3. Record has been perused and the arguments advanced by the learned counsel for the applicant/accused and learned Addl.P.P for the State have been heard.

4. Perusal of the record reveals that the applicant was granted bail in this case vide order dated 05.12.2016 passed by the court of Ms.Sangeeta, Judge Special Court, Ludhiana. Thereafter, the accused/applicant absented himself from the proceedings and was

declared proclaimed offender. The accused was rearrested and is in custody in this case since 12.10.2018. It is a case of recovery of non-commercial quantity. Trial of the case will take some time to conclude. No purpose will be served by detaining the accused behind the beyond a reasonable shadow of doubt for an indefinite period. In these circumstances, it would be appropriate to readmit the accused on bail.

5. As a result of above discussion the application is allowed and the accused/applicant is hereby ordered to be released on bail on furnishing bail bonds in the sum of Rs.50,000/- with one surety to the like amount, subject to the condition that he will not temper with prosecution evidence and shall not leave the territory of India till the conclusion of the trial. Police record be returned. Requisite bail bonds not furnished. These papers are ordered to be attached with the main challan file.
