ORDER

1. Applicant Jasbir Singh @ Jasvir Singh @ Rubal son of Hardeep Singh, has filed the bail application under Section 439 Cr.P.C. and notice of the same was given to the State.
2. Heard. The record reveals that FIR No.13 dated 01.03.2023, under Section 379-B IPC was registered at Police Station Begowal, District Kapurthala, on the basis of statement of

complainant Mohammad Ali Akbar son of Mohammad Irfan, who had stated before the police that he had come from the State of Bihar to Punjab and presently he is doing the work of ladies tailor. He does the work of tailoring at Sabha Boutique situated near Thandha Peer Wali Gali Tahli Chowk, Begowal. Further, complainant had submitted that on 01.03.2023 around 1.15 P.M, he had gone to the main market of Begowal for the recharge of his mobile phone. While he was going on the street situated at Begowal Tanda road to Meekhowal Gurudwara, at that time, he was holding his phone in his hands. Around 1.30 P.M when he reached near the mobile phone shop, meanwhile two clean shaven persons came on scooter of black colour from the side of Meekhowal Gurudwara and when they reached near him, then suddenly the pillion rider snatched his mobile phone which was of make VIVO having SIM No.78776-85062 and then fled away towards Tanda side. He read the registration number of scooter as PB-18-V-8887. Thereafter he at his own level tried to search the accused and lateron it was revealed to him that it was snatched by Jasbir Singh @ Rubal son of Hardeep Singh and Kartar Masih @ Raju son of Shinda Masih. Thus, it was submitted that necessary action be taken

3. Record reveals that the present applicant Jasbir Singh was arrested on 01.03.2023. Even the mobile phone has been recovered from the present applicant. So since the applicant is behind the bars for the last more than five and half months, as such, this Court is of the view that no useful purpose would be served by

detaining the applicant behind the bars for an indefinite period as there is every likelihood that it will take sufficient time in the presentation of the challan. Accordingly, the bail application is allowed and applicant/accused Jasbir Singh @ Jasvir Singh @ Rubal is ordered to be released on bail on his furnishing bail bonds in the sum of Rs.50,000/- with one surety of the like amount, to the satisfaction of this Court. Bail bonds not furnished. File of this bail application be attached with the main file.
