Cross examination by Sri. advocate for Respondent.

I am not an eye witness. I got telephone message by many people and thereafter I went to spot. My wife was the RC owner of two wheeler. It is false to suggest that on the said date my wife was riding high speed. It is false to suggest that my wife applied sudden break on seeing road hump and fell her left side. It is false to suggest that thereafter the lorry went across the deceased. It is false to suggest that despite of my wife's negligent, I have lodged false complaint.

I work in Ocwen finance company. My wife salary was account transferred. I had applied for bank statement but the officials sought for court approval to issue the same. I did not apply the letter to bank since I am not the nominee. there is no bank pass book. It is false to suggest that the employment documents are created for the case. It is false to suggest that

my wife was not earning Rs.70,000 per month. I am married 2½ year to deceased. We did not have issues. It is false to suggest that I did not spend Rs.2,00,000 for funeral and obsequious. I am the only son and I have two sisters. My father is retired Govt employee. It is false to suggest that I was not dependant on deceased salary. It is false to suggest that despite of my wife negligence, I have created police documents in collusion with them.
