Six accused persons namely 1) Dul Dul Mullick, 2) Sabir Ali, 3) Moidul Mullick, 4) Khoka Mullick, 5) Saidul Mullick and 6) Sahabuddin Mullick on C.B are present by filing hazira.

Today is fixed for consideration of charge.

Ld. P.P.In-charge opens his case and submitted that there is sufficient prima facie evidence against the accused persons. So, he opens his case by describing the charge brought against accused persons and stating that what evidence he has proposed to prove the guilt of the accused persons.

Heard Ld. Advocate for the accused persons on the point of charge. He submitted that there is no sufficient prima facie evidence against accused persons.

Perused the record, the documents there with and the case diary.

Having heard submission of both sides and on perusal of the record of the case, the documents submitted therewith and the case diary, I am of the opinion that there is sufficient ground for presuming that the accused persons have committed offence punishable under sections **120B/302/324/323/34 of I.P.C.**

Accordingly, I frame charge against the accused persons namely 1) Dul Dul Mullick, 2) Sabir Ali, 3) Moidul Mullick, 4) Khoka Mullick, 5) Saidul Mullick and 6) Sahabuddin Mullick in writing for trial under sections **120B/302/324/323/34 of I.P.C.**

Let the separate sheet containing charge against the accused persons be kept with the record.

The contents of the charge so framed are read over explained to the accused persons in Bengali and they pleaded not guilty and claimed to be tried by saying “ Amra Nirdosh”.

Hence, fix 22.08.2018 for evidence of C.S.W no. 1 (complainant),

Fix 23.08.2018 for evidence of C.S.W. no. 2.

Fix 24.08.2018 for evidence of C.S.W. no. 3.
