

Order No. 24 dated: 18-07-2023.

An application has been filed on behalf of the accused person, namely Ainul Sk., along with a fresh vokalatnama as well as certified copy of the order dated 04-07-2023 passed by the Hon'ble Court in CRM (N.D.P.S) 1207 of 2023, along with an affidavit by the Ld. Counsel, affirming the genuinity of the said copy of order. It is prayed for on behalf of accused person, namely Ainul Sk. that he be allowed to furnish bail bond, as directed by the Hon'ble High Court.

Perused the impugned application, as well as the certified copy of the order passed by the Hon'ble Court.

Heard.

It appears that the Hon'ble High Court, Calcutta has been pleased to order as follows :

"....., the petitioner Viz. Ainul Sk., shall be released on bail upon furnishing a bond of 10,000/- each, with two sureties of like amount each, one of whom must be local, to the satisfaction of Ld. Judge, Special Court under N.D.P.S Act, Howrah, subject to condition that he shall appear before the trial court on every date of hearing until further orders and shall not intimidate witnesses or tamper with evidence in any manner whatsoever. In the event petitioner fails to appear before the trial court without any justifiable cause, the trial court shall be at liberty to cancel their bail automatically without reference to this court.

It is manifest from the record that Hon'ble Court has been pleased to grant bail to the accused person and he has filed an application intending to furnish bail bond in terms of the order passed by the Hon'ble Court.

The prayer is considered and allowed. The accused person is liberty to furnish bond, as has been stipulated by the Hon'ble Court.

The said Bani Kumar Samanta also files affidavit before Judicial Magistrate, 4th Class, Howrah in respect of accused person, namely Ainul Sk., affirming the genuinity of the said deed. The said Bani Kumar Samanta also files bail bond as local security on behalf of accused person, namely Ainul Sk.

Sourav Mishra files bonds of behalf of the accused person, namely Ainul Sk. as registered securities respectively. The said bail bond appear to have been duly checked and fitted by the bail bond officer.

Perused the same, as well as other materials on record.

Heard the Ld. Counsel Mr. Sanglap Mukherjee, appearing on behalf of accused person.

The bail bond by the local security Bani Kumar Samanta, depositing registered deeds nos.I-050601804/2023, dated 25-04-2023, of ADSR, Bagnan, Howrah is found sufficient and hence accepted.

The bail bond filed by registered security Sourav Mishra appears to have checked and fitted by the bail bond officer and hence the same accepted as well.

The accused person, Ainul Sk. appear to have satisfied this court regarding the bail bond that the Hon'ble Court have directed him to furnish before this court in CRM (NDPS) 1207 of 2023. As such, release him at once.

Issue release order in respect of accused person, namely Ainul Sk. directing the correctional home authorities to forthwith release the accused person from custody, if he is not wanted in any other case.
