ORDER:

1. Heard, on the regular bail application under Section 483 of BNSS 2023 moved by the applicant-accused Manav alias Mowgli
2. Upon notice, bail application is opposed by learned

Additional Public Prosecutor for the State on the ground that allegations against accused are serious and he cannot be granted bail because the offence is heinous in nature.

2.1. ASI Vimal Kumar. 1317/PTK, PS Division No. 1 Pathankot has tendered proforma containing brief of the case duly attested by SI/SHO Mandeep Salgotra No 28/BTRT .

2.2. It is submitted in the proforma that FIR under Section 21,61-85 of NDPS Act has been registered against accused Anil Kapoor. The contraband weighing 06 grams 90 milligram Heroin was recovered from his conscious possession of Anil Kapoor. Thereafter, on the basis of disclosure statement made by accused Anil Kapoor the applicant Manav alias Mowgli, Vivek Sharma alias Commando and jojo were nominated as accused in this case, who disclosed in his disclosure statement that the recovered Heroin was purchased by him from Manav alias Mowgli and others.

2.3. The applicant was arrested on 15.11.2025. One other FIRs i.e. (1). FIR No.65 dated 06.05.2025, *under Sections 21, 61-85 NDPS Act PS Division No. 1* , Pathankot, had already been registered against the applicant-accused. Report of FSL has not been received. Prayer for dismissal of the bail application has been made.

3. Police record shows that the co-accused Anil Kapoor has been apprehended in the area of Old Court Complex Dalhousie Road and 06 grams 90 milligram Heroin was recovered from his conscious

possession, which is “*non commercial quantity*”. Co-accused Anil Kapoor has suffered a disclosure statement that the Heroin which has been recovered from applicant the same was purchased by him from Manav alias Mowgli and others. The applicant is in custody since 15.11.2025. However, one other FIR as mentioned above had already been registered against the applicant-accused. Hence, it cannot be said to be continuing offence in drugs. Trial will take time. No useful purpose will be served by keeping the applicant-accused in custody, rather it will be burden on the State Exchequer. Without commenting on the merits of the case, the applicant-accused Manav alias Mowgli is ordered to be released on regular bail, subject to his furnishing bail bonds in the sum of ₹.1,00,000/-with one surety in the like amount, subject to the following conditions:-

- 1). that he shall attend the court on each and every date of hearing;
- 2). that he shall not leave India without prior permission of the trial court;
- 3). that he shall not directly or indirectly make any inducement, threat or promise to any person acquainted with facts of the case so as to dissuade him from disclosing such facts to the court or to any police officer or tamper with the evidence;
- 4). The furnishing of above bonds shall be deemed acceptance that once the trial begins, the applicant shall not, in any manner, try to delay the proceedings, and undertakes to appear before the concerned Court and to attend the trial on each date, unless exempted. In case of an appeal, on these very bonds, the applicant also promises to appear before the higher Court in terms of Section 437-A Cr.P.C.
- 5). The accused as well as surety shall submit atleast two of the following documents at the time of furnishing the bonds:
 - (a) Passport,

- (b) Pan Card Copy,
- (c) Bank Passbook,
- (d) Credit Card with photograph,
- (e) Ration card,
- (f) Electricity bill,
- (g) Landline telephone bill,
- (h) Voter ID Card issued by the Election Commission of India,
- (i) Property Tax Register,
- (j) Aadhaar Card.

- 6). The accused as well as surety shall inform the police authorities as well as court about the change of his/her residential address, if any.
- 7). In case the accused is involved in similar cases again, the prosecution is at liberty to file an application for cancellation of bail.

4. Nothing stated here-in-above shall have any bearing on the merits of this case. Bail application of applicant is hereby allowed accordingly. Copy of this order be sent to the court of learned Ilaqa/Duty Judge, for information and necessary compliance. File be consigned to the Judicial Record Room, Pathankot after its completion.
