FIRST APPLICATION FOR ANTICIPATORY BAIL U/S 438 CR.P.C.

Present:- Sh. B.S. Dhakala Adv, counsel for applicant/accused.
Sh. K.S. Gill learned Additional P.P. for the State.

ORDER.

1. This is an anticipatory bail application under Section 438 Cr.P.C. moved by Sh. B.S. Dhakala, Advocate on behalf of accused Gaurav Trehan in FIR No. 111 dated 28.06.2018 U/S 420 IPC registered at Police Station City Batala.

2. On 16.07.2018, interim relief was granted to accused/applicant by passing following order:-

“ This is an anticipatory bail application under Section 438 Cr.P.C. moved by Sh. B.S. Dhakala, Advocate on behalf of accused Gaurav Trehan in

FIR No. 111 dated 28.06.2018 U/S 420 IPC registered at Police Station City Batala.

2. Upon notice, Shri K.S. Gill, Ld. Addl. P.P has appeared on behalf of the State.

3. Record produced.

4. Arguments heard.

5. Contention of Sh. B.S. Dhakala, Advocate for applicant/accused is that appellant/accused namely Gaurav Trehan has been falsely implicated under political pressure. He argued that written agreement has been signed between the parties on 30.03.2018. It is infact complainant who is not performing that terms of that agreement. His argument is that Civil dispute between the parties is also going on. Accused/applicant has already performed part of agreement dated 30.03.2018. Civil dispute has been given the shape of criminal offence. He argued that accused/applicant is ready to join investigation to fully cooperate with the investigating agency.

7. Adjourned to 23.07.2018

8. In the meantime, accused/applicant is directed to join the investigation and to fully cooperate with the investigating agency. On his doing so, accused/applicant Gaurav Trehan is ordered to be released on interim bail

on his furnishing bail bonds and surety bonds to the satisfaction of IO/Arresting Officer, subject to conditions laid down Under Section 438 Cr.P.C.”

3. Today ASI Sarwan Singh No. 2450/BTL came present alongwith record to record his statement to the effect that applicant/accused has joined investigation and his further custody is not required in the present case.
4. Accordingly, this court considers that no useful purpose would be served by taking the applicant in custody.
5. Present application for anticipatory application succeeds and same is hereby allowed and order dated 16.07.2018, whereby interim bail was granted is hereby made absolute.
6. Police record be returned and file be consigned to record room.
