ORDER:

1. Present application filed on behalf of applicant/accused
Lakhwinder Singh @ Lakhu seeking pre arrest bail in the matter, details
of which have been referred above, shall be disposed off through this
order.
2. The FIR in this case was registered on the statement of
complainant Kiran wife of Vicky whereby, she informed that she is house
hold lady. She is pregnant of three months. On 16.06.2025 at about 10:30
PM, she, her husband Vicky and father-in-law Ladu Ram were sleeping in

the courtyard of their house, then all of sudden, by breaking the main gate of their house, Sukh Sahota @ Kalu son of Japsal Singh armed with iron pipe, Maninder Singh @ Deepa son of Hardial Singh armed with kapa, Gurbaj Singh, Kaka sons of Lakhwinder Singh armed with dang and Lakhwinder Singh son of Kaku Ram armed with dang residents of Jandwala Bhime Shaha entered inside their house. Maninder Singh stated to catch hold and to teach lesson to Ladu Ram for having dispute with them. In the meantime, Maninder Singh gave kapa blow which hit on left side of forehead of her father-in-law Ladu Ram and Sukh Sahota @ Kalu gave iron rod blow which hit on the left bicep of her father-in-law. She and her husband Vicky came forward to rescue her father-in-law on which Maninder loudly stated that they may also come. Then Gora son of Nirmal Singh armed with kapa, Ekam son of Maninder Singh armed with kapa, Bohra son of Judge armed with sword, Akash @ Kashi son of Ganju armed with kapa, Lakhwinder Singh @ Lakhu son of Gurmukh Singh, Satnam Singh son of unknown armed with kapa alongwith 15-20 unknown persons armed with kapa, kirpans also entered inside their house. Gurbaj Singh gave dang blow which hit on her head. Kaka gave dang blow which hit on back of bicep of left arm. She fell down on which, Maninder Singh, Ekam and Lakhwinder Singh @ Lakhu gave kick blows on her stomach. Her husband came forward to rescue her on which, the assailants also manhandled him. They raised alarm on which Malkiat Singh son of Bagga Singh came to their house on which Maninder Singh gave kapa blow which hit on forehead of Malkiat Singh and then Sukh

Sahota gave iron pipe blow which hit on back side of right shoulder of Bagga Singh. Thereafter, Satnam Singh, Akash @ Kashi and unknown persons also damaged the motorcycle, fan, cots lying in their house. Maninder Singh stated that Malkiat Singh and Jeet Singh are also associates of Ladu Ram and they be also taught lesson for helping him. Out of the aforesaid assailants, some went to the house of Malkiat Singh and Jeet Singh and by entering inside their house, the assailants caused damage to their houses. The assailants also damaged their doors, windows. On alarm being raised by them, the people from the village started gathering at the spot and on seeing them, the aforesaid assailants fled away from the spot alongwith their respective weapons. While leaving, the assailants also took with them cylinder, gas stove and Tullu pump.

3. Notice of the bail application was served upon the State through learned Additional PP alongwith copy of bail application, who received the same, appeared and contested the bail application on merits. Police record was requisitioned which has been received and perused.

4. I have heard the respective contentions of both the learned Advocates and have perused the record with their able assistance.

5. The applicant-accused was armed with kapa. He alongwith 11 named and 15 to 20 unknown persons attacked the complainant who is a female i.e. Kiran wife of Vicky in a very gruesome manner and later on when Malkiat Singh came to her rescue, he was also given kapa blows and blows with iron pipe etc. the accused not only stopped at this but also

damaged the motorcycle, fan and the bed lying in the house. Thereafter, the accused party went to the house of Malkiat Singh and Jeet Singh for helping Ladhu Ram which was the motive of occurrence and also broke the house hold articles lying there. Now the manner in which the occurrence has taken place and group of accused attacked a female complainant and other person namely Malkiat Singh and the way in which the damage has been caused to the house, the gravity of the offence has increased and in such circumstances no ground is made out to allow the pre arrest bail application hence, the same stands dismissed. File be consigned to the record room.
