ORDER

Bail application has been put up before the undersigned being
Judge on Duty.

2. Applicant has sought regular bail under section 439
Cr.P.C.

3. Notice of the bail application was given to the Addl.PP
for the State who opposed the bail application and prayed for dismissal of
the same.

4. Police record was called which has been received and perused.

5. Heard. Considered. In this case FIR has been registered on 13.04.2022 on the brief contents that police during patrolling duty and checking of suspected persons received secret information that one Sajan @ Kuttu is habitual of committing theft and now after committing theft of one iron box of electric meter from the area of Improvement Scheme No.7 Tibri Road Gurdaspur by loading on the E-Vehicle Rickshaw going towards Bhai Lalo Chowk and if checking be conducted he may be apprehended with the stolen iron box. Accordingly Sajan was arrested and from him stolen iron box of electric meter was recovered and he admitted the theft and also disclosed that he was going to sell the same to the scrap holder and FIR was registered.

6. On 14.04.2022 Sajan confessed that earlier he alongwith Sushil @ Shabhu, Sukhwinder Singh @ Mithu, Rahul @ Chini and Deepak jointly committed robberies and theft and the said stolen articles used to be kept by Sushil and he only knows about the same and can get recover the said articles.

7. On 16.04.2022 Sukhwinder Singh after arrest confessed that he alongwith Gurpreet @ Gopy and Ram Tirath committed the theft and stolen articles i.e. iron was used to sold to Ajay Kumar Scrap Holder. Today they also sold 40 Kg iron grills and sticks to Ajay Kumar for Rs.2000/- and they distributed the said amount. He also confessed that

he and Gurpreet Singh also committed theft of seven motorcycles and only Gurpreet Singh knows about it that to whom the said motorcycles have been sold. He and Gopy also have committed theft by driving motorcycle snatched the gold chains from the women and he used to give the said stolen golden articles to Baldev Singh Sarpanch and Shakuntala @ Babbi and with the sale proceed he used to purchase the intoxicant substance to which he may got recovered.

8. In this case Sajan has been arrested on 13.04.2022. Sukhwinder Singh has been arrested on 16.04.3033. Ajay Kumar has been arrested on 16.04.2022. Ram Tirath @ Ram has been arrested on 17.04.2022 and Rahul Kumar @ Chini has been arrested on 12.04.2022 and offence under section 379-B IPC also has been added in this case.

9. In this case recovery has already been effected. Role and liability of the applicant will be seen during trial. Applicant is named as accused on the confessional statement. Presentation of challan and trial will take time. Role and liability of the applicant will be seen during trial. There is nothing on record that applicant is previous convict of similar offence or any other offene. So, in the meantime, further detention of the applicant behind the bar for indefinite period. Accordingly, bail application is allowed and applicant is ordered to be released on bail on his furnishing bail bond in the sum of Rs. 50,000/- with one surety in the like amount to the satisfaction of Trial/Illaqa/Duty Magistrate subject to the conditions that he shall appear in the court on each and every date of

hearing and shall not put influence on the prosecution witnesses and shall not leave the country without prior permission of the court. With these observations the bail application stands allowed and disposed off. Bail file be sent to the concerned court immediately for consignment purpose.
