Out of eight accused persons on C.B, six accused persons are present by filing hazira and one accused person, namely, Sk. Asgar @ Saheb Sk is absent by filing a petition u/s 317 with a prayer for allowing him to be represented through his Ld. Advocate.

No report is received from the Inspector-in-Charge of Sankrail P.S with regard to the present status of the accused person, namely, Asmira Begum.

Ld. PP-in-Charge is present.

Ld. Advocate for the accused persons is present.

Now, the petition u/s 317 Cr.P.C is taken up for hearing.

The petition u/s 317 Cr.P.C is hereby allowed subject to the condition that the accused petitioner will challenge his identity at any stage of the trial.

On perusal of the case record, it appears that on 27.02.2026, on the basis of one petition, filed on behalf of accused Asmira Begum, this Court had directed the Inspector-in-Charge of Sankrail P.S to submit a report with regard to the present status of the accused person, namely, Asimara Begum,, wife of Sk. Jikria @ Jigria Sk fixing 15.06.2026 for appearance and report from the concerned Inspector-in-Charge and the said order was dully communicated by this Court vide this Court's Memo No.141, dated 06.03.2026. On further perusal of the case record, it also appears that in spite of communication of the said order, the Inspector-in-Charge of Sankrail P.S did not submit any report before this Court and accordingly, this Court on the next date i.e. on 15.06.2026, vide its order being No.43, dated 15.06.2026 further directed the Inspector-in-Charge of Sankrail P.S to submit the report with regard to the present status of the said accused person, namely, Asmira Begum fixing today's date i.e. 04.07.2026 for appearance of the accused persons and for report from the Inspector-in-Charge of Sankrail P.S and the said order was also communicated by this Court vide this Court's Memo No. 329, dated 15.06.2026.

Considering the above fact sand circumstances of this case, the Inspector-in-Charge of Sankrail P.S is directed to personally appear before this Court with written explanation showing the reasons of non-compliance of this Court's order along with the report regarding the present status of the accused person, namely, Asmira Begum, wife of Sk. Jikria @ Jigria Sk.

Let a copy of this order be sent to the Inspector-in-Charge of Sankrail P.S for information and compliance.

Let another copy of this order be sent to the Commissioner of Police, Howrah Police Commissionerate with a request to pass necessary direction upon the Inspector-in-Charge of Sankrail P.S ensuring the compliance of this Court's order.
