Today is fixed for appearance of the accused persons and consideration of charge.

All five accused persons on C.B, namely, Bajrangbali Biswakarma, Sandhya @ Rina Biswakarma, Raju Biswakarma, Amit Biswakarma & Sumita Moshal is present by filing hazira. They have filed a petition praying for confirmation of their interim bail on the ground stated therein. Let the same be kept with the case record.

They are represented by their learned advocate.

Ld. PP-in-charge is present with C.D.

Now, the case record is taken up for hearing of the petition praying for confirmation of their interim bail.

Heard both sides. Considered.

On perusal of the case record, it appears that the investigation officer has submitted charge-sheet under Section 306/34 IPC against the accused persons 30.11.2018 and since after the transfer of this case to this Court by the Ld. Sessions Judge, Howrah, the accused persons are regularly attending this Court.

Considering the above, the petition praying for confirmation of the interim bail of the accused persons is allowed.

Let the interim bail of the accused persons be confirmed.

The accused persons are permitted to remain on the same bail bond.

Now, the case record is taken up for consideration of charge.

Ld. PP-in-Charge opens his case in support of the charge.

Heard the Learned PP-in-Charge as well as Learned Advocate appearing for the accused persons.

Perused the case diary and other materials on record. Considered.

On perusal of the materials on record, it appears that there are sufficient grounds for presuming that the accused persons, namely, Bajrangbali Biswakarma, Sandhya @ Rina Biswakarma, Raju Biswakarma, Amit Biswakarma & Sumita Moshal have committed the offence punishable u/s 306/34 I.P.C and as such charge is framed against the above stated accused persons punishable u/s 306/34 of the Indian Penal Code.
