



Order dated 13.03.2026

Sole accused **Dilip Routh** entered appearance, along with fresh Vakalatnama and prays for bail.

The warrantee accused, **Dilip Routh** surrender today. The accused is remanded to J/C.

Bail petition is filed on behalf of **Dilip Routh**.

Heard. Considered.

Considering the voluntariness of the accused person, he may find bail of Rs. 500/- with one surety.

Subsequently, bail bonds of Rs.500/- is filed by Regd. surety namely, Hemanta Bar bearing Book No.H Page 35 on behalf of the accused, **Dilip Routh**.

The bail bonds **so filed are found fit and the same are accepted. Accordingly Recall W/A..**

One petition has been filed on behalf of the accused, praying for pleading guilty.

For expedite trial, the C.R. is taken up for plea hearing.

Ld. APP is present with C.D.

Heard the Ld. Advocate for the accused and the Ld. APP at length. Perused the available materials.

The accused person is examined under Section 251 of Cr.P.C. for the offence punishable under Section 279/427 of IPC and the substances of the accusation is read over and explained to the accused to his communicable language, to which he pleaded guilty by saying 'আমি দোষী'.

The plea of guilt appears to be voluntarily made and the accepted.

The accused is convicted under Section 252 Cr.P.C. for the offence U/s. 279/427 of Indian Penal Code, 1860 and the accused is sentenced to pay fine of Rs.500/- for each offence i.e. totaling to Rs.1,000/- (Rupees One Thousand Only) for the above stated offence, i.d. to S.I. for one month.

The instant case be disposed of after realization of fine amount.
