ORDER.

1. Gurwinder Singh alias Bhinda (here-in-after to be referred as bail applicant) have moved an application under Section 483 BNSS, for grant of regular bail in case FIR No.202 dated 22.11.2025, under Section 21, 27 of the NDPS Act, Police Station Boha.

2. Upon notice, Ld. Addl. Public Prosecutor has appeared to represent the State and to contest the bail application.

3. I have heard learned counsel for the applicant and learned Addl. PP for the State and have gone through the record carefully.

4. Ld. Counsel for applicant contended that latter is innocent and has been falsely implicated in this case. Nothing has been recovered from him. Applicant/accused has been in custody since 22.11.2025 and is not required for any

investigation purpose. Presentation and disposal of challan will take time. Therefore, the prayer to admit applicant to regular bail.

5. Ld. Addl.P.P. opposed the prayer seeking dismissal of application in view of the nature of offence.

6. As per version of Investigating Agency, applicant/accused Gurwinder Singh alias Bhinda alongwith his co-accused Jagandeep Singh was apprehended on 22.11.2025 by the police while allegedly possessing 07 grams Heroin (Chitta). Recovery of contraband already has been effected. Applicant being in judicial custody is not required for any investigation purposes. Presentation and disposal of challan will take considerable time. Culpability of applicant will be decided in regular trial. Therefore, without commenting on merits of the case, accused/applicant is admitted to regular bail on furnishing his personal bonds and one surety bond, each of Rs.50000/- to the satisfaction of Ld. Illaqa/Duty Magistrate. A copy of this order be sent to court concerned. Bail application file be attached with remand papers which be returned to Ahlmad.
