**ORDER
(Delivered on 03.09.2025)**

1. The present application has been filed by the applicant/
accused seeking regular bail under Section 483 of BNSS, in the subject
captioned FIR.
2. Notice of the bail application was given to the prosecution.
Shri S.K. Sachdeva, learned Additional Public Prosecutor appeared to
contest the bail application. Record has been requisitioned.

3. Shri Gurnishant Singh, learned Advocate has submitted that the latter has been falsely implicated in the present case. Nothing is to be recovered from the applicant/accused and the alleged recovery has been foisted upon him as he was not present at the spot. The applicant/ accused is in judicial lock up since his arrest. No useful purpose will be served by detaining the accused in custody. With these submissions, he has prayed for the grant of concession of bail to the accused/applicant.

4. Per-contra, Shri S.K. Sachdeva, learned Additional Public Prosecutor for the State has argued that applicant/accused is involved in a serious offence, so he is not entitled for the concession of bail. It has been prayed that the bail application be dismissed.

5. I have heard rival contentions of both the sides and perused the record.

6. The present FIR has been lodged on 23.07.2025, on the basis of secret information regarding involvement of applicant/accused Tarsem Singh alias Soma along with co-accused Nikka son of Jasvir Singh, Babal son of Jaswinder Singh, Bohar Singh son of Nachhatar Singh, Bala son of Kaur Singh in committing decoities. Secret informer further informed that all the aforesaid persons while armed with deadly weapon are making preparation for committing dacoity while sitting near canal bridge in the area of Panj Grian Kalan to Sivia road. If raid is conducted, they can be apprehended red handed. On the basis of said information, case was registered. Raid was conducted at the disclosed place, from where accused Tarsem Singh @ Sema (applicant) armed with iron Datter, Jaswinder

Singh @ Nikka son of Jasvir Singh armed with an Axe, Akashdeep Singh @ Babal son of Jaswinder Singh armed with kirpan, Bohar Singh son of Nachhatar Singh armed with iron khanda and Buta Singh @ Bala son of Kaur Singh armed with iron Sabbal, were apprehended and arrested at the spot. As per record, applicant/accused was arrested on the basis of secret information. Alleged recovery has already been effected from the applicant/accused, who is in custody since 23.07.2025. Conclusion of investigation and trial is likely to take a long time. No useful purpose will be served by keeping the accused/applicant in custody for an indefinite period. Hence, without commenting on the merits of the case, the applicant/accused is ordered to be released on bail on his furnishing bail bonds/surety bonds to the satisfaction of learned Illaqa/Duty Magistrate subject to the conditions that he shall not, directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the court or the police, that he shall not tamper with prosecution evidence in any manner, that he shall not leave country without prior permission of the court and that he shall appear on each and every date of hearing before the trial court.

7. The bail application stands allowed accordingly. A copy of this order be sent to the quarter concerned. File be consigned.
