As such, they are taken into custody. It is submitted on behalf of the petitioners that they are innocent and have committed no offence. They have been falsely implicated in this case by the informant. They have already deposited the damaged amounts. They are ready to furnish suitable bail bonds. Thus, they may be enlarged on bail. On the other hand, learned A.P.P. conceded this fact. It is a case under section 135 of the Indian Electricity Act. Petitioner No. 1 Rakesh Mukhi has deposited the loss amount
