ORDER

The accused/applicant has filed the instant application under Section 439 of the Code of Criminal Procedure. ASI Sat Pal has produced the record of investigation

2. Arguments are heard. As per prosecution version, the applicant/accused was apprehended by the police party on suspicion and

recovery of 15 gram heroin was made from his conscious possession on 26.05.2023.

3. The applicant is in custody since 26.05.2023. It is a case of recovery of noncommercial quantity of intoxicating substance. Completion of investigation, presentation of challan and conclusion of trial will take sufficient time and no useful purpose would be served by detaining him in custody. In these circumstances, this Court is of the considered view that the applicant is entitled to get concession of bail. Therefore, his application is allowed and he is ordered to be released from custody on furnishing his personal bail bond in the sum of Rs.25,000/- (Twenty Five Thousand) with one surety in the like amount to the satisfaction of Illaqa Judicial Magistrate/Duty Magistrate at Zira or Ferozepur subject to the following conditions:

- (I) That the applicant shall not leave the country without the prior permission of the Court;
- (II) That the applicant shall make himself available for interrogation by the Investigating Officer as and when required;
- (III) That the applicant shall not, directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the Court or to any police officer;
- (IV) That the applicant shall regularly attend the hearings before the trial Court.

The Illaqa Judicial Magistrate/Duty Magistrate is directed to send the bail/surety bonds along with relevant documents after accepting

and attesting the same to this court. A copy of this order this order be sent to learned court of Illaqa Judicial Magistrate forthwith. **Ahlmad is also directed to send soft copy of this order by e-mail to the concerned Jail Superintendent for compliance of order dated 31.01.2023 of Hon'ble Supreme Court passed in SMWP (Criminal) No.4/2021.** File of this bail application be attached with the file of remand papers.
