Order No. 26 dated 03.02.2023

Today is fixed for E/R of W/A of accused persons namely Dipankar Manna and Bedana Manna. Accused Dipankar Manna is produced under arrest on the strength of W/A issued by this Court. Perused the forwarding letter, medical documents, memo of arrest. Let them be kept with the record. Accused Dipankar Manna be taken into custody.

Received N.E.R. in respect of another accused namely Bedana Manna.

One application for bail is filed on behalf of accused Dipankar Manna which is backed by one Vakalatnama duly accepted by his Ld. Lawyer. Let it be kept with the record.

Ld. P.P.-in-charge is present. Copy of the application for bail is served.

Ld. Lawyer for the accused person submits that due to illness of his parents the accused could not make himself available before this Court when the case was called for, nor he make necessary interaction with his earlier Ld. Lawyer on record to enable him to take proper step on his behalf. In support of his submission Ld. lawyer for the accused person has produced photocopies of bunch of medical documents. According to him the father of his client, aged about 79 years, is suffering from various ailments and needs to be treated almost on regular basis.

Accordingly Ld. Lawyer for the accused person prays for bail for his client, on any condition, whatsoever. Ld. P.P.-in-charge leaves the matter to the discretion of this Court.

Record speaks that it was 15.12.2022 both the accused persons involved in this case were found absent without any step when the case was called on. It further appears that on consecutive two dates preceding to 15.12.2022 both the accused persons were also found absent, but steps were taken on their behalf by the Ld. Lawyer.

Being an inquirer of this proceeding, this Court has traversed through the photocopies of documents relating to the treatment of the father of the present accused person. Both the accused persons were on regular bail and it is only their misuse of the liberty granted to them for which the accused person is now standing behind the iron bar. Ld. Lawyer for the accused persons submits that his client could make himself available before this Court on each and every date to be fixed in future.

Considering the totality of the documents available before this Court, this Court finds ground to extend a further opportunity to the present accused person by enlarging him an interim bail and on certain conditions enumerated herein below.

**The prayer for bail is allowed. The accused person namely; Dipankar Manna may find an interim bail of Rs. 2000/- (Rupees Two Thousand only) with two registered Sureties of Rs. 1000/- (Rupees One Thousand Only) each, subject to the satisfaction of the Ld. Judicial Magistrate, Amta, Howrah, and on condition to remain present before this Court on each and every date of this proceeding, failing**

**which cancellation of this Order would be a matter of course following issuance of W/A against him.**

**If on bail, to 06.03.2023 for appearance and E/R of W/A of accused Bedana Manna.**
