The cross examination of the said PW-1 is deferred on the prayer of the ld. Advocate for accused persons namely, Sk. Amirul Ali , Asraful Ali Mallick @ Abu Bakkar.

The custody accused is remanded to further J/C till next date i.e. 25.02.2026.
