Contd... 29.11.2022	further submitted that the petitioners are father-in-law and mother-in-law of the informant and they have been compromised their case outside the court through their well wishers. He has further submitted that both party have been compromised their case willingly on the basis of compromise they did not want to proceed with their case. Hence he may be released on bail. The Ld. APP opposed the prayer of defence counsel. Heard and perused the case record from which it appears that court has taken cognizance for the offence U/s 498A/34 of IPC and U/s 34 of Dowry Prohibition Act against above named petitioners and one other person namely Kamran Ansari vide order dated 23.07.2020. It also appears that NBW and notice to bailors has issued vide order dated 10.06.22. It further appears that both parties have compromised the case. Considering the above facts and circumstances, this Court is inclined to release the petitioners namely Kalam Ansari and Siratun Khatoon on bail on furnishing bail bond of Rs. 10,000/- with two sureties of like amount each.
