Today is fixed for hearing of the application u/s 483 BNSS.

Ld. Advocate appearing for the accused/petitioner viz Bipradip Biswas @ Sohag Biswas is present and submits that no application for bail either U/S 482 BNS or U/S 483 BNS has been preferred, rejected or pending before any higher forum in respect of the present accused/petitioner and to that effect an affidavit has been filed.

In compliance of the directions contained in the Order dated 20.02.2026 passed by the Hon'ble Supreme Court of India in Writ Petition(s) (Civil) No(s). 1089/2025 with W.P.(C) No. 126/2026, W.P.(C) No. 129/2026 (PIL-W), W.P.(C) No.737/2025 (PIL-W), W.P.(C) No.1074/2025 (PIL-W), W.P.(C) 1088/2025 (PIL-W), W.P.(C) No.1216/2025 (PIL-W), W.P.(C) No. 159/2026 (PIL-W), W.P.(C) no. 119/2026 (PIL-W) and IAs connected therewith, the PO is busy with SIR work.

ADJ-2, Uluberia is in-charge.

Bail petition is taken up for hearing.

Ld. Advocate appearing for the accused/petitioner submits that :-

- 1) His client is in custody since 31.12.2025;
- 2) He has been falsely implicated in this case;
- 3) Investigation has fairly proceeded.

Contending thus he prayed for enlarging his client on bail.

Ld. P.P in-charge raises objection against the prayer for bail citing the materials collected in the CD.

Perused the materials on record and the CD.

Heard both sides. Considered.

Considering the C.D, all other materials on record, I find that accused/petitioner is named by the I.O. as habitual offender and in the forwarding report dated 09.01.2026 the nine other cases which are pending against the accused have been specified. Investigation is going on. Serious allegation of financial fraud has been advanced against the accused. Earlier this court vide order dated 13.02.2026 rejected the prayer for bail of the accused. In such circumstances I am not inclined to enlarge the accused/petitioner on bail. Hence, the prayer for bail stands rejected.

Thus the Criminal Misc. Case no.110/2026 is disposed.
