The above parties and advocates, if any, will report to the Ld. Mediator, Uluberia. If it is not possible to mediate this case on the date fixed, the Mediation Centre/ Ld. Mediator /Concerned authority will arrange a future date for mediation convenient to the parties, if necessary.

If a settlement agreeable to the parties is reached, the terms shall be recorded by the Ld. Mediator and signed by the parties,/their counsel and returned to this Court for further appropriate orders.

If no settlement is reached, neither the parties, the advocates, nor the Ld. Mediator may disclose to this Court anything that was discussed at the mediation.

Having regard to the nature of the case, the fees of the Ld. Mediator be fixed at a consolidated amount of Rs. 3,000/- in terms of Rule 26A(2) of the existing Mediation rules, as amended, on settlement of the case through mediation.
