CONDITIONS :-

The said investment shall carry the following terms and conditions:-

- (1) The interest on the Fixed Deposit Investment as and when it becomes due, shall be paid to the applicant(s).
- (2). No loan, over-draft or advance known by any other name or nomenclature, shall be made available on the said fixed deposit investment and the bank shall not allow any encumbrance on the said fixed deposit.
- (3). The bank shall intimate to the Tribunal the particulars of the fixed deposit investment, such as the date of investment,

number of F.D.R., date of maturity, etc. immediately after the issue of F.D.R.

- (4). At the end of the stipulated period of 05 years as aforesaid, the Bank shall pay the principal amount of F.D.R. with interest accrued thereon, if any, by an account payee cheque to be drawn in the name of the respective applicant(s).
