Statement of process servers regarding the execution of process against **accused no. 2** are recorded separately. This court is satisfied with the mode and manner of the proclamation and execution of process under Section 82 Cr.P.C.

Perusal of the records shows that the **accused no. 2** has been absconding & is not traceable by due process of law. In view of the report of the process servers u/s 82 Cr.P.C. & the statements recorded today, this court is of the view that the accused no. 2 is evading arrest & avoiding due process of law. The accused has not appeared despite proper publication of process and lapse of statutory period. There is no possibility of early apprehension of the accused.

Accordingly, **accused no.2 namely Kamal Manchanda, Director of M/S GTHS RETAILS P LTD** is declared as a Proclaimed Person.

Let intimation be sent to the concerned SHO to register FIR against the accused under relevant provisions and take necessary action to secure his presence.

File be consigned to Record Room after due compliance.

Proceedings against the accused be revived as and when he is apprehended/arrested.
