Contd... 01.02.2023	deposited the said cheque for encashment in his account running at State Bank of India, Lohardaga but the said cheque was dishonoured on 07.11.2022 by the Banks on the ground of “Payment stopped by drawer” and thereafter a legal notice was sent to the accused through his advocate Mr. Moti Lal on 21.11.2022 which was not received due to locked door and notice returned on 29.11.2022 but never repaid the same and accordingly filed this complaint case on 19.12.2022. In support of this version SA of the complainant with an affidavit has been filed. Heard. Perused the complaint petition alongwith documents as well as Solemn Affirmation on affidavit of the complainant which shows the fact that as per Section 138 of NI Act, the case was filed within time and accordingly, I find there is sufficient material for the offence U/s 138 of NI Act and a prima facie case is made out for the offence U/s 138 of NI Act. Further from the perusal of the complaint petition alongwith documents as well as Solemn Affirmation on affidavit of the complainant, the accused namely Anand Yashvir Toppo is involved in this case and there is sufficient material
