Today is fixed for Production of the CCL, Counselling Report from the CCI, SIR and CD along with situation report from I.O.

Ld. PP-in-charge is present. No members are present due to dissolution of earlier Board on 19.10.2025.

CCL is produced today from Sahid Bandana Smriti Balika Abas, Cooch Behar with proper escort. She is taken into safe custody.

CD and situation report is received from I.O in c/w this case.

No SIR is received till today.

No Guardian/Zimmdar of the CCL has turned up today to take custody of the CCL as a fit person.

Ld. Remand Hour Advocate files one bail application and prays for bail on any terms and condition.

Thus, the record is taken up for hearing of bail petition.

Heard submission of Ld. Advocate for the CCL as well as the Ld. PP-in-charge.

Ld. PP-in-charge raised objection.

Now the record is taken up for hearing of bail petition.

Perused the CD and materials available on the case record.

Perused the situation report of the area where the CCL resides filed by the I.O of this case.

Perused the same and it appears that the tension is still prevailing at the area where the CCL resides and there is every chance that the CCL may be manhandled if she released on bail today.

Considering all aspects and keeping in mind the safety, security and welfare of the child, release of the CCL at the moment can render him psychological and physical danger and the release of the CCL will defeat the end of justice.

Hence, the CCL is remanded to protective custody at Observation Home for safety, security and welfare and also rendered psychological counseling.

As such prayer for bail is rejected at this stage.

CCL is remanded to protective custody in Observation Home.

GRO, JJB is directed to make necessary arrangement to produce the CCL before Sahid Bandana Smriti Balika Abas, Cooch Behar with proper escort, safety & security.

The escort team is directed to take care regarding the safety & protection of the CCL during transit to Sahid Bandana Smriti Balika Abas, Cooch Behar

The Superintendent, Sahid Bandana Smriti Balika Abas, Cooch Behar is directed to make necessary arrangement for regular counseling of the CCL while in place of safety and forward all reports on the next date fixed positively.

The Superintendent, Sahid Bandana Smriti Balika Abas, Cooch Behar is further directed to ensure safety, security of the CCL during her stay at the Korok Home, Jalpaiguri.

Let a copy of this order be served upon the Superintendent, Sahid Bandana Smriti Balika Abas, Cooch Behar at once.

Call for CD & fresh situation report from the I.O. on next date fixed positively.

Let a copy of this order be sent to I.O through O/C of Sahebganj PS for his information and compliance.
