date as 08.02.2021 from the clerk of his counsel and whereas actual date was 06.02.2021 and when on 08.02.2021 the accused-applicants came present in this Hon'ble Court he came to know that he has been marked absent on 06.02.2021 and his warrants have been issued by the Ld. Lower court of Ms. Radhika Puri, the then JMIC, Amritsar on 06.02.2021. That the absence of the accused-applicants on 06.02.2021 in the Ld. Lower court was not intentional but due to to abovesaid reason. That the accused-applicants will remain vigilant in future regarding court hearing. That the accused-applicants will abide by the terms and conditions imposed by the Hon'be Court and will not temper with the prosecution evidence while on bail. With these contentions prayer is made for grant of bail.

2. Notice of the bail application was given to Additional P.P. for the State, who put her appearance and opposed the bail application.

3. Record was requisitioned, received and attached. The perusal of the file shows that the accused-applicants did not appear in the trial court on 08.01.2020 and notice to both of the accused-applicant was issued for 06.02.2020 and on 06.02.2020 as both the accused-applicants have not

appeared, their bail bonds were canceled and forfeited to the State but their bail order was not canceled and the same is intact till date. So as the bail orders of the accused are intact till date. So the present bail application is not maintainable. Accordingly, the present bail application is hereby dismissed. However the accused-applicants are at liberty to approach the Ld Trial court and seek their remedy as per law. File be returned. Bail application be consigned to the Record Room.
