

**Complaint Case No. 45<sup>c</sup> of 2025**

**Order Date 23.04.2025**

Today is fixed for hearing of the petition filed by the complainant regarding issuance of non-bailable warrant of arrest against accused persons viz. Alok Kumar Mishra and Sidharth Kumar Sinha.

Ld. APP is present.

The complainant alleged in their application that during the course of investigation it has come to their knowledge that the above mentioned persons are involved in such criminal activities and in spite of their repeated try, D.D.C.A., Bihar has failed to trace and arrest the said accused persons and despite of efforts the complainant has been unable to make contact with the accused persons. It is further alleged in this application that the accused persons are influential in nature and are such are absconding to evade the law of the land.

Ld. APP raised no objection and further supported the application and submits her hearing before this Court necessity of passing of this order.

Heard and considered.

At the very outset it must be quite clearly visible that the instant case is based on the basis of allegation against the accused regarding involvement of alleged offence engendering public health and safety.

Moreover perused the record C.D. and other materials presents, it is prima facie appeared that a large cartel involved in trade of spurious and adulterated prescription drug in the State.

Having meticulously gone through the instant application and it is further appears to me that for the further investigation and determination of exact truth the present application must be allowed and considered for the sake of justice.

*Thus, the instant application is hereby allowed and considered.*

Further another application regarding allow the custody of the seized article in favour of complainant under Sections 23(5)(b) and 23(6) of the Drugs and Cosmetics Act, 1940 is hereby allowed and considered. Thus report in respect of the same filed on 17.04.2025 is kept with the record and considered.

Further it is hereby directed to issue Non-bailable warrant of arrest against the accused persons **viz. Alok Kumar Mishra, Son of Ashok Kumar Mishra, residing at Road No. 3, P.O. & P.S. Rampur, Shastri Nagar (West), District–Gaya, Bihar, Pin–823001 and Sidharth Kumar Sinha, Son of Amarnath Sinha, residing at Shamir Takiya, near Middle School, Gaya Town, P.O.–Chandchaura, District–Gaya, Bihar, Pin–823001.**

It is further directed to Superintendent of Police Gaya to execute the E/R of N.B.W.A. against aforesaid accused persons and treat the matter as extremely urgent. It is further directed to him after arrest also intimate the same to the S.P. Rural Howrah H.R.D. and Directorate of Drug Control, Howrah District Drug Control Office, West Bengal for necessary information.

Copy forwarded to Superintendent of Police Rural Howrah(HRD) to communicate and transmit the same to the above mentioned concerned authority for E.R. of N.B.W.A along with order sheet.

A copy of order sheet is further directed to send to **O.C. Rampur, Shastri Nagar (West)** for further assistance to the concerned S.P. Gaya, regarding execution of the instant order.

Complainant to file requisite at once. G.R.O. to do needful and I.O. to inform and take necessary action.
